### **Description:**

While the presentation will focus on works of art, it will also touch on archeological items and other collectibles covering the following aspects:

- 1. The financial risks to Trustees of incomplete provenance on works of art
- 2. Incomplete provenance being a major risk to trustees when buying, selling or on-boarding works of art
- 3. How to manage any provenance risk in any collection
- 4. The steps trustees should go through to identify and manage any restitution risks to an art collection.
